# **LACIGF Review and Analysis Process**



## LACIGF review and analysis process

- 157 interviewees
- Blank canvas approach
- Stocktaking on LACIGF's accomplishments and future needs
- Improvements according to six (6) categories: Participation,
  Content, Format, Structure, Intersessional Work, Financing



## **Participation**

- More information dissemination actitivities
- Earlier availability of details on agenda, speakers, etc.
- Enhanced collaborative spirit
- Formal communication to Governments through MFAs
- Inclusion of High-Level governmental meetings



#### Content

- More concise agenda
- Greater recognition of region's diversity
- Issue selection
  - Combine public consultations with consultations with actors and local IGFs
- Produce outcomes
  - Many options. Summarise discussions, identify priorities and when possible, group/align significant principles and/or action lines related to an issue
- Do not repeat content or discussions



#### **Format**

- More interactive/innovative
  - Continue the break-out sessions experience
  - Moderated discussions without formal panelists (town hall)
  - Debates
- Less repetition of speakers and moderators
- Enhanced transparency in the selection of speakers and moderators



#### **Intersessional Work**

- More continuous work, better focused on ongoing issues as opposed to yearly meeting
  - Virtual thematic working groups
  - Enhanced communication with other forums and organisations
  - Relay relevant content raised at LACIGF to competent authorities
  - Improve information repository



#### **Structure**

- Steering Committee with greater leadership and visibility
  - Equal commitment and dedication from all members
  - Clear roles and responsibilities
  - Clarity in eligibility criteria and processes

Significant support for the creation of a dedicated Secretariat



# Financing

- Continue present model based on donations (Trust Fund pooling of donations)
  - If LACIGF gains more relevance, there will be more interested parties to contribute

Analyze complementary membership models

# **LACIGF 13 – 8/10 September 2020**



Over time, the Regional Preparatory Meeting for the Internet Governance Forum, LACIGF, has become a true regional meeting space for multistakeholder policy debate where different stakeholders representing governments, the private sector, the technical community, academia and civil society organizations share and discuss their views.

Over the past few years, the region has made progress in understanding current Internet governance challenges, creating a space for debating and identifying regional priorities that has significantly broadened the region's participation in the Internet Governance Forum (IGF).

In addition, since its earliest editions, one of the meeting's goals has been to inform regional stakeholders on the topics and trends observed during global IGF debates and discussions. Likewise, in a process that began in 2008 during the first Regional Preparatory Meeting for the Internet Governance Forum, the debate surrounding the IGF global agenda is now being regionalized.
